




3. Online resources for students and faculties:

Resolution: No further points are up for discussion. The meeting concluded with gratitude extended to the chairman and all the members in attendance.






3. Stakeholders feedback review:

6. Review of NAAC /AQAR status:







Punishment:-


- 1. Cancellation of Admission


